### SILICA

Crystalline Silica may be present. Crystalline silica may cause irritation to eyes, skin and the respiratory tract. Prolonged or repeated inhalation of silica, in excess of TLV, may lead to delayed lung injury (silicosis). This material is listed as a possible carcinogen.

Routes of Entry: Ingestion. Absorption through skin negligible. Inhalation only if sprayed.
